He explained that this schedule was created in 1997 and was still in the portrait format, so has not been viable since the Infolinx implementation. Of the six series, five are being updated to current standards, with *License Register and Supporting Reports* being made defunct and superceded by multiple GS-102 series. He also explained the inclusion of several new Code citations. There was no discussion.
